CT State USBC News

CT State USBC & CT USBC Youth held its 8thAnnual Meeting on June 28, 2015, at AMF Colony Lanes in Wallingford, CT. A total of 41 delegates attended. President, Pat Lupacchino, presided over the meeting and introduced new Association Manager, Denise Troy, who presented financial reports. Various Board Directors gave committee reports. Delegates were able to ask questions or express areas that might concern them. Proposed amendments to the bylaws were presented by Tom Kapitan, Sr., Chairman of the Legislative Committee, and voted on by the assembly. All pertained to reducing the number of directors from 16 to 14, creating a new stagger system for director terms, and reducing the quorum for meetings from 11 to 10. All passed. An election for officers and directors whose terms were up was held. Re-elected to the CT State USBC Board were Annie Gallant, Quen Martin, Dolores Voelker, and Barbara Watts. Re-elected, as officers were, 1st Vice President, Scott Hockford, and Sergeant-at-Arms, Tom Kapitan, Sr. Elected as 2016 USBC National Delegates were Annie Gallant and Paul DiMauro.

Prior to the meeting, 1st Vice President, Scott Hockford, conducted a Memorial Service for all certified CT State USBC bowlers who died this year. Representatives from each local association participated in the ceremony.

Special thanks went to interim Association Manager, Dolores Voelker, who held the position until someone could be hired. She spent many hours training and easing Denise into the duties the position entailed.

It was disappointing to have so few delegates at this meeting to vote on important issues or share ideas. The state and local associations are the bowlers' vehicles to run tournaments and events that benefit thousands of certified bowlers, from youth to seniors. They are run by volunteers who give up their time, expenses, and efforts to attend meetings, travel throughout the state, and work at these activities to give bowlers a chance to compete, earn scholarships for their children and grandchildren, and receive honors and awards due them. If someone doesn't like the way something is done we hear about it but very few take their opportunity to create change. They like to complain but offer little help to make the organization improve its services. If you can't take the time to become a state or local director, please consider becoming a volunteer to work in an area of interest. If you can't volunteer, please attend local and state annual meetings for a few hours out of an entire year to make your voice heard. Let's have a much better turnout next year!


CT State USBC Hall of Fame Members Pass
